THEREFORE BE IT RESOLVED: That said contract by and between the said City of Polson, Montana, a municipal corporation, and the United States of America in pursuance of Act of August 19, 1949, (Public Law 255, 81 Congress; 63 Stat. 621) relating to a system of drainage and sanitation for said City of Polson Montana is hereby authorized to be entered into by said City and said Mayor of said City is authorized and directed to execute the same for and on behalf of said City, and said city acting thru its said council approves said contract in each and every respect and in its entirety and binds itself to the terms and provisions contained therein,

That the City of Polson Montana hereby agrees and does, hold the United States of America harmless for damages that may be claimed by any property owner as resulting from seepage in the affected area, and the drainage-sanitation district so formed pursuant to section 1, of said contract, which contract is referred to herein, specifically agrees to hold the United States harmless against any and all damages or damage claims that may be asserted by property owners of the area affected,

That the City of Polson Montana, does hereby accept title to the said system in perpetuity, and does hereby aggee to operate and maintain said system in perpetuity.

That the said city of Polson Montana does hereby accept all the terms and

provisions of said contract and binds itself thereby.

That an emergency exists in the city of Polson, Montana, and the said city council does hereby declare that an emergency to exist, nand that it is necessary for the peace, safety and health of said City and its inhabitants that this resolution become effective immediately upon its passage and approval, and by reason thereof, this resolution does become effective immediately upon its passage and approval.

That any and all resolutions, if any there be, in comflict herewith are

hereby repealed.

ORDINANCE NO. 239

AN ORDINANCE PROVIDING A METHOD FOR OILING THE STREETS WITHIN OILING DISTRICT NO 14-1, PAYING FOR THE SAME AND CREATING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA.

SECTION 1. That all of the streets included within oiling District No. 14-I shall be oiled during the summer season of 1952 by forces employed by the City of Polson.

SECTION 2. That the cost and expenses of sprinkling said streets with oil shall be assessed against all of said property, exclusive of public parks and public places, embraced within such oiling district upon an area basis.

SECTION 3. WHEREAS: An emergency exists and it is necessary for the preservation of the peace, health and safety of the public that this ordinance take effect immediately upon its passage and approval.
