A RESOLUTION CREATING OIL DISTRICT NO. 14-K, DEFINING THE BOUNDARIES THEREOF AND DESIGNATING THE COST THEREOF.

BE IT RESOLVED BY THE City Council of the City of Polson, Lake County, Montana: SECTION 1. That an oil sprinkling district, to be known and designated as Oil District No. 14-K is hereby created.

SECTION 2. That the boundaries of said Oil District No. 14. -K are and shall be as to include all of the area or that portion of the City of Folson including the streets upon which the following described lots and blocks border: All of Elocks 1, 2, 3, 4, 5, 6, Lots 2 to 12 inclusive in Block 7, Lots 1 to 12 inclusive in Block 8, all of Blocks 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, and 31 of the Original Townsite of the City of Polson. All of Blocks 1 and 2, Lots 1 and 7 to 16 inclusive in Block 3, all of Blocks 4, 5, 6, and 7 of Riverside Addition to the City of Folson. Lots 6 and 7, Block 2; Lots 1 and 12, Block 6; Lots 6 and 7, Block 4; Lots 7 to 12 inclusive of Block 10; Lots 1 and 12, Block 6; Lots 6 and 7 of Block 12; Lots 5 and 6 of Block 10; Lots 1 and 12 of Block 11; Lots 7 to 12 inclusive of Block 14; Lots 7 to 11 inclusive of Block 13; Lots 1 to 6 inclusive of Block 14; Lots 6 and 7 of Block 15; Lots 6 and 7 of Block 18; Lots 1 and 12 of Block 19 of the Grandview Addition to the City of Folson. Lots 1 to 4 inclusive of Block 1 and Lots 5 to 8 inclusive of Block 2, Follmann Addition to the City of Folson. Hank Meyers property, Lots 6 and 7 in Block 2; Lots 1 to 6 inclusive in Block 3; Lots 7 to 12 inclusive in Block 4; Ben McNeeley, Brank Bare, Leo James properties; Lots 6 and 7 in Block 7, Polson Heights Addition to the City of Folson. Lot A in Block 12; Lots 1 and 12 in Block 17, and Hospital Emock of Pend D' Creille Heights Addition to the City of Folson. Lot 1 of Block 1; Lots 22 to 24 inclusive of Block 8, Roman Catholic Bishop (Church) and the Northern Pacific Railway Property; Lots 12 to 25 inclusive in Block 4; Lots 1 to 12 inclusive inBlock 5, and Lots 1 to 12 inclusive in Block 2; Michel Addition to the City of Folson. Lots 1 to 6 inclusive in Block 2; Lots 1 to 6 inclusive in Block 2; Lots 1 to 6 inclusive in Block 2; Lots 1 to 6 inclusive in Block 3, and Lots 1 to 4 inclusive in Block 1, Lots 1 to 6 inclusive in Block 1, Lots 1 to 6 inclusive

SECTION 3, That an emergency exists and it is necessary immediately for the preservation of the peace, health and safety of the inhabitants of the City of Polson that this resolution shall have effect immediately upon its passage and approval.

SECTION 4. That the estimated cost of oiling said district as aforesaid shall be the sum of \$6,000.00, approximately or not to exceed the sum of \$7.50 per lot.

SECTION 5. That all resolutions or parts thereof in conflict herewith are hereby repealed.
