

RESOLUTION NO. 862

RESOLUTION TO APPROPRIATE MONEY AND PROVIDE FOR THE PAYMENT OF DEBTS AND EXPENSES OF THE CITY OF POLSON AS ALLOWED BY MCA 7-6-4006.

WHEREAS, pursuant to MCA section 7-6-4006 the City Council of the City of Polson, Montana, may appropriate money and provide for payment of debts and expenses of the local government.

WHEREAS, appropriations may be adjusted by passage of a resolution stating the adjustment, which is the procedures authorized by the governing body for:

- debt service funds for obligations related to debt approved by the governing body,
- trust funds for obligations authorized by trust covenants,
- any fund for federal, state, local, or private grants and shared revenue accepted and approved by the governing body;
- any fund for special assessments approved by the governing body;
- the proceeds from the sale of land,
- any fund for gifts or donations, and
- money borrowed during the fiscal year.


WHEREAS, the following adjustments to the 2003 budget are proposed and deemed necessary,


- Add \$239,000 to 1000 101000 to facilitate a commercial loan from 1st Citizens Bank to purchase a fire truck,
- Add \$8,573 to 2870 101000 so the City may spend unanticipated grant monies,
- Add \$8,000 to 5310 101000 so the City may spend unanticipated grant monies,
- Add \$1,000 to 7060 101000 so the City may spend unanticipated grant monies.

NOW BE IT RESOLVED by the Polson City Council that:

- \$239,000 be added to 1000 420400 906,
- \$8,573 be added to fund 2870 420141 299,
- \$8,000 added to 5310 430630 300,
- \$1,000 be added to 7060 460430 200 for the unanticipated expenditures.


