

RESOLUTION NO. 871

A RESOLUTION OF ANNEXATION

WHEREAS, the City of Polson has received a Petition for Annexation from CARL A. SEIFERT and GERTRUDE M. SEIFERT, husband and wife, pursuant to M.C.A. Section 7-2-4601; and

WHEREAS, the City of Polson finds that the Petition is signed by the owner of the territory to be annexed, which property is adjacent to the existing corporate boundary of the City of Polson, said property being described as follows, to-wit:

*32 Violet Lane*

A tract of land in the SE1/4SW1/4 of Section 2, Township 22 North, Range 20 West, MPM, Lake County, Montana, more particularly described as follows:

Beginning at a point which is distant North 610 feet and East 95.4 feet from the SW corner of said sub-division; thence North 2 degrees 36 minutes East 269.6 feet to intersect the Southerly boundary line of the Northern Pacific right-of-way; thence along said right of way line S. 59 degrees 00 minutes East 38.2 feet; thence continuing along said right of way S. 37 degrees 29 minutes East 102.2 feet; thence S. 13 degrees 20 minutes West 203.3 feet; thence N. 66 degrees 00 minutes 64.2 feet to the place of beginning. NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON:

That the corporate limits of the City of Polson, a municipal corporation, are hereby extended to include that property described above.

The property is to be zoned MRZD.

The annexed real property shall be in Voting Ward 2

The Clerk is directed to prepare a certified copy of this Resolution and file same in the office of the Clerk and Recorder of Lake County.

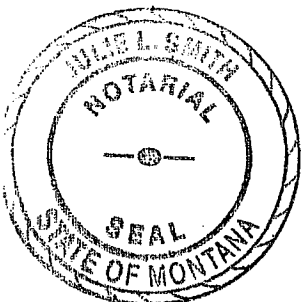
