## RESOLUTION #911

CITY OF POLSON APPROVING AND ADOPTING THE REVISED AND RESTATED INTERLOCAL AGREEMENT GOVERNING THE MONTANA MUNICIPAL INSURANCE AUTHORITY

WHEREAS, the City of Polson is an incorporated city of the third class, duly organized under the laws of the State of Montana; and

WHEREAS, Title 7, Chapter 11, Part 1, Montana Code Annotated (MCA), authorizes political subdivisions to create interlocal agreements to jointly perform any undertaking that each of them is authorized by law to perform; and

WHEREAS, Section 2-9-211, MCA authorizes political subdivisions of the state, separately or jointly with other subdivisions, to procure insurance to use a deductible or self-insurance plan, wholly or in part, and to establish a selfinsurance or deductible reserve fund; and

WHEREAS, the Montana Municipal Insurance Authority (hereinafter "Authority") is an intergovernmental authority credited pursuant to the Interlocal Cooperation Act, §2-9-211, MCA, for the purpose of providing one or more risk protection programs for the benefit of participating Montana cities and towns; and

WHEREAS, the City of Polson is a Member of the Authority; and

WHEREAS, the Authority has determined that a REVISED AND RESTATED INTERLOCAL AGREEMENT GOVERNING THE MONTANA MUNICIPAL INSURANCE AUTHORITY is necessary to govern the operations of the Authority;

WHEREAS, Section XXV of the existing INTERLOCAL AGREEMENT CREATING THE MONTANA MUNICIPAL INSURANCE AUTHORITY requires two-thirds of governing boards or councils of the Authority's Members to approve amendments and revisions to the Interlocal Agreement;

NOW, THEREFORE, BE IT RESOLVED THAT the City of Polson hereby approves and adopts the REVISED and RESTATED INTERLOCAL AGREEMENT GOVERNING THE MONTANA MUNICIPAL INSURANCE AUTHORITY and directs the appropriate Officer of the City of Polson to execute the same.

I, Randolph B.
