RESOLUTION #937

A RESOLUTION TO ADOPT A BUDGET FOR THE CITY OF POLSON, MONTANA FOR THE FISCAL YEAR 2006-2007.

WHEREAS, pursuant to MCA section 7-6-4021 the City Council of the City of Polson, Montana held a public hearing on the proposed budget on Wednesday, September 6, 2006 at 6:00 p.m. as required by law.

WHEREAS, pursuant to MCA section 7-6-4030 the City Council of the City of Polson has amended its preliminary budget after the public hearing, with consideration of public comment.

NOW THEREFORE BE IT RESOLVED by the Polson City Council;

- 1) that the amended budget be approved and adopted, and that passage of this resolution authorizes appropriations to defray the expenses of liabilities for the 2006-2007 fiscal year in accordance with items set forth in the amended budget, and
- 2) that the Department of Revenue has provided the City of Polson with their certified taxable valuation pursuant to MCA 15-10-202. The taxable valuation of $\frac{56,794,637}{600}$ for district 23P was used to complete the form provided for determination of tax revenue and mill levy limitations under House Bill 124, which yielded $\frac{115.76 \text{ mills}}{6000}$, and
- 3) that the mill levies for fiscal year 2006-2007 be fixed and adopted at 115.76 mills for districts 23P,
- 4) that pursuant to Municipal Budget Law contained in title 7 Chapter 6, Part 40 of the Montana Code Annotated, as allowed by MCA7-6-4031, the Mayor with the approval of the City Council is hereby authorized to transfer appropriations between items within the same fund, and
- 5) that pursuant to Montana Code at 2-9-212, in addition to and above the foregoing mill levy, the City Council held a public hearing on Wednesday, September 6, 2006 and adopted Resolution 937 allowing it to impose permissive mills of 1.24 mills generating approximately \$7.85 per \$100,000.00 of taxable value, or \$6,794 per mill, for a total amount of \$9,752, for the purpose of offsetting increased health insurance premiums for fiscal year 2006-2007.
- 6) that pursuant to the primary election held on June 6, 2006, where a 19.95 mill levy for public safety operations and the purchase of public safety equipment was approved by the voters, which put in place a mill levy of 19.95 which will generate \$135,540\$ at \$6,794\$ value per mill.

The effective date of this resolution shall be July 1, 2006.
