A RESOLUTION TO ALLOCATE UP TO \$15,000.00 IN MATCHING FUNDS FOR ANY GRANT MONIES OBTAINED FROM THE TREASURE STATE ENDOWMENT PROGRAM FOR THE PURPOSE OF FUNDING STUDIES, ANALYSES, OR RESEARCH NECESSARY FOR THE PREPARATION OF A PRELIMINARY ENGINEERING REPORT IN CONNECTION WITH CITY UTILITY INFRASTRUCTURE.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA. LAKE COUNTY THAT THE CITY OF POLSON SHALL APPLY FOR A TSEP-FUNDING MATCHING GRANT, AND THAT THE CITY OF POLSON SHALL ALLOCATE UP TO \$15.000.00 IN MATCHING FUNDS FOR ANY GRANT MONIES OBTAINED FROM THE TREASURE STATE ENDOWMENT PROGRAM FOR THE PURPOSE OF FUNDING A PRELIMINARY ENGINEERING REPORT REGARDING ITS UTILITIES.
