

RESOLUTION NO. 2014-RES #001

A RESOLUTION ESTABLISHING A GOLF CART AREA

WHEREAS, the City Commission of Polson has been requested by individuals within the City limits to allow persons to utilize golf carts for personal transportation on the streets and alleys of Polson in support of the municipal golf course;

WHEREAS, the Commission recognizes the inherent dangers of allowing golf carts on the roadways and that such use may endanger pedestrians, bicycle riders and motor vehicles that utilize such areas;

WHEREAS, the Commission has determined that golf carts will not unreasonably congest the roadways and that through the proper management of traffic the traveling public may be safeguarded from harm;

WHEREAS, it is necessary under the Ordinance allowing the use of golf carts on City roadways to designate a specific area where such traffic will be allowed and to ensure that impact upon pedestrians, bicycle riders and motor vehicles is minimized;

WHEREAS, it appears in the best public interest that the attached Exhibits to this Resolution be adopted as the Golf Cart Area.

NOW, THEREFORE, BE IT RESOLVED by the City of Polson Commission that

The Exhibit attached hereto and made a part hereof shall designate the Golf Cart Area where permitted golf carts may utilize the roadways of the City of Polson.

This Resolution shall be effective on the date that the Ordinance allowing the safe use of carts on the roadways is effective.

All Resolutions or part of resolutions in conflict herewith are hereby amended to the extent of any such conflict.



GOLF CART ZONE RESOLUTION NO. 2014-RES#001

The purpose of the proposed Golf Cart Zone is to allow, **during daylight hours only**, the use of golf carts on City Streets within the boundaries of the proposed zone. These carts will not be required to be equipped with safety features such as headlights, tail lights, turn signals, horn, seat belts, etc. The following provisions should be implemented within the Resolution:

1. Must obey all current City of Polson traffic laws.
2. Limited to one rider per seat in golf cart, two riders per "bench seat".
3. Hours of operation are SUNRISE to SUNSET only.
4. City streets included in the Resolution will be:
 - Country Club Drive
 - Golf Course Road
 - Bayshore Drive
 - Bogey Drive
 - Little Lane
 - Hogan Way
 - Bayshore Lane
 - Bayview Drive
 - Timberwolf Drive
 - Kari Lane
 - Hawk Road
 - Eagle Drive
 - Gwenda Lane
 - Jefferson Court
 - Reliance Landing
 - Gallatin Street
 - Crescent Landing
 - Shawnee Lane
 - Whitefox Run
 - Judith Court
 - Marias Street
 - Montana LandingAll other roads within the proposed zone are private
5. Resolution will NOT include US Hwy 93 or MT Hwy 35
