A RESOLUTION TO ESTABLISH FEES AND CHARGES FOR INSPECTION AND ENFORCEMENT OF THE CITY OF POLSON BUILDING CODES

RECITALS

WHEREAS, the City of Polson (City) has the power and authority, to regulate, establish, and change as it considers proper the rates, charges, and classifications imposed for the inspection and enforcement of the adopted building and construction codes (Section 50-60-106, MCA). Rates, charges and classifications must be reasonable and just;

WHEREAS, the City of Polson finds it necessary to provide for the inspection and permitting of commercial and residential construction and improvements;

WHEREAS, the Commission, by separate ordinance, is amending the Polson City Code to reflect the adopted building codes and the authorization to conduct commercial inspections; and

WHEREAS, it appears in the best public interest that reasonable rates and charges for commercial and residential inspection and permitting be adopted for the public health and safety.

NOW, THEREFORE, BE IT RESOLVED that the City Commission hereby adopts and establishes the following fees, rates and charges for the inspection and permitting of building construction within the City of Polson:

Exhibit "A" attached hereto and made a part hereof.

Section 6. <u>Further Rate Increases.</u> Subsequent adjustment to the rates and charges will be made by a resolution of the Commission in accordance with Montana law.

BE IT FURTHER RESOLVED THAT the City Clerk is hereby instructed to place this Resolution in the City of Polson Book of Resolutions and to hereinafter collect the charges established hereby.
