## **RESOLUTION NUMBER 2023-010**

## A RESOLUTION TO ESTABLISH PRIORITIES FOR THE EXPENDITURE OF TAX INCREMENT FINANCING DISTRICT FUNDS, TO INCLUDE BUILDING AND INFRASTRUCTURE GRANTS.

**WHEREAS**, The Polson Urban Renewal Plan contains a provision that allows for the use of Tax Increment Financing District monies to fund redevelopment activities within the Polson Urban Renewal District; and,

**WHEREAS**, The Polson Redevelopment Agency (PRA) operates a grant program that requires minimum match amounts, establishes requirements for participation, and results in a formal recommendation to the Polson City Commission; and,

**WHEREAS,** the Polson City Commission deems it appropriate to establish priorities for guidance of the Polson Redevelopment Agency board regarding the recommendation of building and infrastructure grants with TIFD funds;

**NOW THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POLSON, MONTANA** that the Polson Redevelopment Agency, and city administration, consider the following guidance when evaluating and recommending building and infrastructure grants to the Polson City Commission:

- 1. Annual budget appropriations for PRA grant projects should be set equal to 1/3 of estimated annual increment for building grants and 2/3 of annual increment for infrastructure grants. (Example, FY 20XX, total increment of \$330,000 = \$110,000 building; \$220,000 infrastructure).
- 2. Applications are encouraged from both private and institutional/business applicants for building grants.
- 3. Annually, the City Manager will submit infrastructure project(s) to the PRA board for consideration of funding; said project(s) to be started within the same fiscal year.
- 4. If the PRA Board deems the funding of a non-infrastructure project of significant community value it may recommend that the Polson City Commission exceed the annual appropriation for building grants, spending TIFD reserve in addition to remaining budget appropriations.

**BE IT FURTHER RESOLVED** that the minutes of the City Commission of the City of Polson, Montana, incorporate this Resolution.
