RESOLUTION TO ADOPT AND ESTABLISH THE GENERAL MILL LEVY, THE PERMISSIVE MEDICAL MILL LEVY, AND THE MUNICIPAL SERVICES LEVY TO BE LEVIED FOR THE CITY OF POLSON IN FISCAL YEAR 2023-2024.

WHEREAS, pursuant to MCA section 15-10-420 a governmental entity that is authorized to impose mills may impose a mill levy sufficient to generate the amount of property taxes assessed in the prior year, plus one-half of the average rate of inflation for the prior three years; and

WHEREAS, the Department of Revenue has provided the City with a certified value of a mill for its taxing jurisdiction under MCA section 15-10-202 being \$14,581.50/mill; and

WHEREAS, the City of Polson has determined the number of authorized mills to be levied using calculations imposed by MCA section 15-10-420; and

WHEREAS, pursuant to MCA section 2-9-212 and MCA section 15-10-420 as amended by SB0491, the City of Polson has determined the number of authorized mills to be levied for the Permissive Medical Mill Levy; and

WHEREAS, the City of Polson has determined that 19.95 mills to be levied, pursuant to the primary election held on June 6, 2006, when a 19.95 mill levy was approved by the voters for public safety operations and the purchase of public safety equipment, known as the Municipal Services Levy; and

WHEREAS, a decrease in property taxes due to MCA section 15-10-420 calculation, permissive, and voted levies of \$49, \$146, and \$292 respectively for a home valued at \$100,000, \$300,000, and \$600,000 is included in this fiscal year budget:

NOW BE IT RESOLVED as established by MCA section 15-10-420, the City of Polson authorizes mills to be set at 138.20 and be levied for fiscal year 2023-2024; and that

- Tax Revenue and Mill Levy – 108.99 mills
- Permissive Medical Mill Levy – 8.51
- Municipal Services Levy – 19.95
