

RESOLUTION NO. RES 2023- 019
A RESOLUTION SETTING PARK FEES

WHEREAS, the City Commission has re-codified the ordinances relating to the operation of special events and has amended the same to provide that fees for the special events will be set by resolution in the City of Polson Schedule of Fees

WHEREAS, it appears in the best public interest for the current taxpayers and users of services provided by the Parks and Recreation Department and to adopt the fees for the use of City services.

WHEREAS, The Golf Enterprise Fund of the City of Polson now falls under the Parks and Recreation Department to adopt the fees for the use of and recreation at Polson Bay Golf Course.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POLSON, MONTANA:

1. The City shall impose and collect the fees as shown on Exhibit "A" and Exhibit "B" attached hereto for the services rendered by the City and the Parks and Recreation Department to include Polson Bay Golf Course.

2. This Resolution shall be effective November 3rd, 2023. All applications for services made prior to this date shall be charged the fees then in existence.

3. All Resolutions or parts of resolutions in conflict herewith are hereby amended to the extent of any such conflict. This resolution repeals and replaces resolution no. RES 2023-__.

BE IT, FURTHERMORE, RESOLVED, that the City Clerk is instructed to file this Resolution in the Book of Resolutions established by this City.
